DEMOLITION PERMIT WORKSHEET

Applicant is responsible for the demolition of the structure pursuant to Oregon Structural Specialty Code (OSSC) Chapter 33.

Please note the Demolition Checklist on the last page must be completed prior to submittal

- Partial demolition permits for commercial projects in preparation for a remodel will be rejected, demolition work in preparation for a remodel will be covered under the remodel permit. Exceptions may be allowed with prior approval of the Building Safety Division. The following criteria still apply.
- In accordance with Oregon Department of Environmental Quality (DEQ) regulations, certain categories of buildings must be inspected for the presence of Asbestos Containing Material (ACM) prior to any demolition/renovation activities. This applies to all facility owners, including but not limited to manufacturing facilities, public and private building owners and operators, commercial facilities, and apartment complexes, and all residential buildings with four or fewer dwelling units constructed prior to January 1, 2004. **Asbestos survey is required prior to issuance of demolition permit**, if the asbestos survey identifies asbestos as being present an asbestos abatement report will also be required. - If commercial type structure demolition impacts fire protection systems including fire sprinklers, fire alarms, smoke detectors, fire suppression systems, fire-rated assemblies, etc. a demolition permit will not be issued until plans are provided demonstrating the integrity of the referenced systems, additional review fees may apply. Fire safety during demolition shall comply with OSSC Chapter 33 and OFC Chapter 33.
- If demolition work impacts paths of egress travel, exits, exit signs or means of egress illumination a demolition permit will not be issued until plans illustrating an approved alternate or temporary means of egress is provided, additional review fees may apply.
- Partial demolition that includes structural load bearing elements and systems will require plans and calculations designed by an Oregon licensed design professional.

- Partial demolition that includes any portion of the foundation will require plans and calculations designed by an Oregon licensed design professional.
- If public protection is required, plans and inspection(s) may be required prior to issuance of demolition permit.
- Adjoining properties shall be protected from damage during construction. Written notice shall be provided to the owners of the adjoining properties advising them of any proposed excavation per OSSC Section 3307 and per Bend Code Title 16.
- A separate Demolition of a Historic Resource application shall be submitted to the Planning Division. The demolition application will be reviewed by the Bend Landmarks Commission through a Type IV public hearing process. - Contact the Oregon Utility Notification Center and schedule an underground utility locate prior to demolition by dialing 811 or visiting their website: <http://digsafelyoregon.com>
- Notify your water and sewer provider, failure to notify your provider may result in continued billing.
- Notify your gas and/or electric company before any demolition begins.
- Solid Waste will need to be contacted at least 48 hours prior to any debris being transferred to the Knott Landfill. Contact them at (541)317-3163 or visit their website:

- For septic tank abandonment contact Deschutes County Environmental Health at (541) 388-6575.
- Notify the Oregon Water Resources Division (503) 986-0900, when wells are present on a property where a structure is going to be demolished.
- Where all buildings are removed from a property, all utilities are required to be underground for any proposed development of the property. <https://bend.municipal.codes/BDC/3.4.600>
