- Applicant must have an open and active non-residential City of Bend utility account located within the Bend city limits and the account must be in good standing
- Applicant must be a named customer or business on the City of Bend Water Services account
- The businesses must be classified under landscaping or automotive NAICS (North American Industry Classification System) codes
- Applicants may only apply once per each physical business address
- Applicant must submit a complete application form; incomplete applications could be denied and returned to applicant, or result in a delay of the issued rebate
- The City may contact applicant by phone or email to verify information provided in the application
- Eligible businesses are subject to available funds
- An application does not guarantee funding, funding is dependent upon applicant meeting the Terms listed in this application
- City of Bend reserves the right to modify or terminate the rebate program at any time.
- Rebate will be administered through a check to applicant within 60 days of final approval
- Effective start date of the program is June, 2025
