

Reversion Deferral & Transfer Fee Program

The Bend Municipal Airport (BDN) recently completed an update to the Rules & Regulations, Minimum Standards, and Leasing and Development (R&R's). In developing the Leasing and Development Policy BDN took note of its obligation to make sure it is adhering to Airport Sponsor Grant Assurances. [Grant Assurances \(Obligations\)](#). [Federal Aviation Administration \(faa.gov\)](#), specifically Assurances 5,22,24, and 38, which if violated would put in jeopardy all past and future Federal grants. This is the Federal Aviation Administration's (FAA) way of ensuring the highest and best use of grant assurances for federal property, protecting the federal investment in our nation's airports.
