

# Riverfront Street



- 2-way street with parking on one side
- Narrow 40-foot right of way
- Failing pavement: width of 24 feet (curb to curb)
- Damaged 4-foot-wide sidewalk
- 4-foot-wide landscape strip dominated by existing utilities

# Project Background

- 2012 Bend Park & Recreation District (BPRD) bond measure approved
- 2013 BPRD began design process
- 2014 – 2017 public outreach and alternatives development
  - 60% plans developed for a “Shared Street Hybrid Concept”
  - Concept plans developed for three 10-foot trail alternatives
- 2017 project halted due to growing complexity, need to replace the street

# Project Background

- 2023 BPRD and City of Bend enter into an intergovernmental agreement
  - City of Bend will lead project with technical & financial assistance from BPRD
  - Design costs are split 50/50
  - Designs will include a minimum 8-foot-wide accessible path

# Project Objectives

- Provide a multi-use trail that connects the missing segment of the Deschutes River Trail
- Rebuild Riverfront Street to address failing pavement conditions
- Replace existing water main and relocate services as necessary
- Upgrade existing stormwater system to include pre-treatment
- Improve the transitions at Miller's Landing Park and Gilchrist Avenue
- Provide parking on one side of Riverfront Street
