2. City of Bend Land Acknowledgement Statement:

Kathi Barguil, She/Her, Community Relations Manager & HREC Staff Liaison read the statement aloud about the city currently developing a sovereignty acknowledgment and ways to support Warm Springs.

She also acknowledged our immigrant and migrant community members. Stating, today is a day without an immigrant and the local Latino Community Association (LCA) is celebrating and standing in solidarity.

3. HREC Business: Agatha Ventura, Chair.

a. Minutes: Approval of November 17, 2025, Draft Minutes

c. Leadership Nomination Accepted and Voted on at the January 2026 Meeting:

The following HREC Leadership roles reviewed and discussed with the Commissioners. Commissioners interested in volunteering for any of the leadership positions can email HREC Staff Liaison Barguil before the January 13, 2026, HREC meeting.

- Chair | Vice Chair | Council Connector | Commissioner Connector.
- New Role: Community Connector needs defining and the suggestion of more than one person/ team for this role due to commissioners' capacity.
 - Chair Ventura, if there is a vacancy with minimal, is interested in the Community Connector role.
 - Commissioner Vernoitico stated that if there was a vacancy that requires minimal time, they would be interested in that role. Their capacity to help is currently limited.

d. New Topic – Non Agenda Item: Best Practices for Email Communications in reference to future public records requests regarding commissioners' personal emails accounts.

City Attorney Leitheiser – Commissioners Responsibility: Commissioners considered public officials including public records and public records in Oregon.

- If someone submits a public record request, there are maintenance obligations that anybody has if you create, store, maintain, have, received things that are public record.
- Best practice for HREC and City Business: Create a separate email address, from your personal email address. Example: Name@gmail.com.

This is a thoughtful way to know when you are wearing your personal or community/commissioner hat and keeping information of public records in a certain place.

- When using your personal cell phone and trading texts about HREC and City business, this falls under public record, subject to retention and obligation.

4. HREC Council Liaison Update: Megan Perkins, She/Her, Mayor Pro Tem.

Council Highlights:

- Electrification: Most Council have decided to continue with the idea of a fee for new residential homes when deciding to use gas.
- Discussion about urban renewal strategy for out three urban renewal districts.
- The Latino Community Association will give an update to city council and talk their combined work with council. Making council aware and preparing for activity from ICE in our community and what can be doing as a city council and a city.
- We will hear from the Bend Central District Business Association, who are trying to create an EID (Economic Improvement District). Where they collect fees or taxes to use on in the specified area.
- January 14, 2026, where they will talk about complete communities. How do we make sure people in our community live near a doctor, grocery store, park, and things what can we do to create those complete communities? They will also talk about Juniper Ridge, temporary safe stay areas.
- January 21, 2026, council will hear from the legislative contingent to talk about what we want out of the legislature, starting in February, and what are things our regional legislators want from the short session.

a. HREC Staff Liaison Updates: Kathi Barguil, She/Her, Community Relations Manager & HREC Staff Liaison.

January

- Ben Duncan, Kearns & West will:
 - Provide a process and project update, including key themes from interviews and HREC considerations.
 - Summarize HREC feedback on approaches for future supports and structures, specifically the commission's insights into what needs we should be considering, as options considered.

Commissioner Fischer asked what community partners met with Ben Duncan from Kearns & West, in reference to future equity work. HREC Interim Liaison shared that she gave a list of names to Ben: Asian Pacific Islander Collective, NeighborImpact, Latino Community Association, COCC, Afrocentric club program coordinator and Kolovita Bend for Ukraine group.

6. Public Comment:

- David Carlson, pronouns – They/Them: Campaign manager for OPEN (Organization for Polyamory and Ethical Non-monogamy) policy. Working to bring non-discrimination protection to people across the country and specifically here in Oregon, they have five campaigns open at the municipal level, to create a new legal class called family and relationship structure. Currently, Portland is about to pass this policy. This policy attaches to existing civil rights ordinances, using the current methods of enforcement, costing the city almost nothing to implement.

7. Roundtable of HREC Commissioners:

- **From the HREC inbox:**
 - **Letter of Support - English2Spanish:** Central Oregon's local translation and interpretation service provider: PacificSource Community Solutions (PSCS) recently notified English 2 Spanish (E2S) that they will not renew our contract for 2026. At the same time, they have chosen an out-of-region company to take over language services for PacificSource members in Central Oregon. They are asking for individual support letters.
HREC Staff Liaison Barguil has proposed to ask for a support letter on behalf of English2Spanish to PacificSource of the individual commissioner or the opportunity as a body.

Liaison Barguil: City council, the language access coordinator Lindsay Wengloski, and council coordinator Clair Conklin are workshopping a letter in partnership with city council to send.

City Attorney Leitheiser: Council decided and delegated a couple council members to collaborate with staff on this letter.

Motion: Commissioner Vernoico made a motion in support of and to reflect in council letter to PacificSource to support English2Spanish. Commissioner Jones seconded. Commissioner in attendance at today's meeting approved.

- **Santa Express Community Event:** Concerns about the routes chosen, not being equitable and the three chosen areas. Only the NW, SE, and SW quadrants visited, not the historically low-income quadrant of the NE. The community members feel discriminated against because of his identity as a homeowner in the NE quadrant for not having a higher income. Angered because his seven-year-old child will not be able to participate.

Liaison Barguil: The Bend Fire Department does not function as a distribution hub. The Salvation Army manages that aspect of the event. Sent express, organized by the Bend Firefighter's Union and supported by Bend Fire and Rescue who participate as volunteers on their own time. The department provides the engine for events; the crew does not participate.

Liaison Barguil will provide a follow-up email to this community member with this information and ways to submit a request for next year's event.

Commissioners discussed and made suggestions for future events.

- **Renter's Rights Commissioner Vernoico:** There are minimal resources for renters in Bend or recourse. Commissioner Vernoico explained their situation before moving into the apartment site unseen, trusting pictures given. The pictures did not resemble the apartment represented in the pictures shared. They are currently experiencing no heat because the radiators are not working, and electricity grounding issues, and the basement is locked with no access to breakers. Where does someone go to help with remediate rental issues?

Suggestions and information mentioned for advocacy: Oregon residential landlord tenant act. This is a body of state law that governs tendencies, habitability, landlord obligation, tenant rights, preempt local law. Bureau of Labor Industries has a civil rights department that investigates fair housing claims. Legal Aid Services of Oregon (LASO). Advocacy group - Community Alliance of Tenants (CAT). Resolutions Northwest.

- **New Topic – Non-Agenda Item: Chair Ventura read message she wrote about a safe and welcoming environment in Bend - Timestamp 1:38:32.**

Commissioners shared their feelings about the resignation and the investigation report about the Bend's Equity and Inclusion Director. They also wanted to know about how they can access a copy of the investigation report.

City Attorney Leitheiser stated that it is available by submitting public records request. The City Attorney will talk to HREC Staff Liaison what works best for getting this investigation report to the Commissioner.
